

## **2009 ARKANSAS STATE FAIR YOUTH TALENT CONTEST**

### **October 12-17, Arkansas State Fairgrounds**

ONE REGIONAL WINNER from each category will be chosen from each Regional Contest held from Monday through Thursday. These Regional winning acts will receive a trophy and return on Saturday for the Finals. One winning act will be chosen from each category in the Finals. These Final winning acts will receive a trophy and cash award. One overall Grand Champion will receive a trophy and an additional cash award. The Bob Evans Memorial Award will be presented to the best non-finalist at each competition. All events will be held in the Arkansas Building southwest of the Coliseum.

### **QUALIFICATIONS & RULES**

1. The purpose of the Arkansas State Fair Youth Talent Contest is to discover, develop, and encourage talent in the youth of Arkansas. It is designed primarily for amateur talent, but any act which qualifies otherwise is eligible even if the act received pay at some time EXCEPT where the person(s) are actually engaged in the entertainment business or paid instructors of the Arts. Acts that may be considered professional should be brought to the attention of the County / District Fair Manager who will be responsible for notifying the State Competitive Events Administrator and / or State Youth Talent Director. The State Competitive Events Administrator and the State Youth Talent Director will determine the contestant's eligibility. Their decision will be final.
2. Contestants must not be less than 10 years of age on the opening day of the Arkansas State Fair nor more than 20 years of age on the last day of the Arkansas State Fair. Any contestant appearing younger or older than the age limits specified should be prepared to furnish proof of age to the State Contest Director.
3. Contestants must be legal residents of Arkansas and cannot be, or at any time have been, married, pregnant, or have had or sired a child. Contestants must never have been convicted of any crime nor have any criminal charges pending.
4. Past Grand Champion Winners of Arkansas State Fair Youth Talent Contests are not eligible to compete again in any category. Contestants in the Arkansas State Fair Youth Talent Contest are not eligible to compete in the Arkansas State Fair Queen Pageant or the Rodeo Queen Contest in the same year.
5. Contestants are not allowed to compete in more than one category unless the second category is with a group of five or more. No contestant will be allowed to compete in more than two categories.
6. Contestants must compete in and win the Youth Talent Contest sanctioned by their County or District Fair. Contestants must legally reside in the county they represent for six months immediately preceding the county contest or must be a full-time student who has attended school (academic, not dance, etc.) in that county for one full semester immediately preceding that county's contest. In the event a contestant's parents are divorced and live in separate counties, and has been court ordered to reside jointly with both parents, the contestant can only compete in one of the two counties in which the contestant's parents reside
7. In the event a contestant legally resides in one county but is attending school in a different county in Arkansas, the contestant may compete at the county level in one and only one of these two counties.

8. Contestants entering the State Contest as a representative of one of the following District Fairs must meet the residency requirements for that District: North Central District Fair, Northeast Arkansas District Fair, Northwest Arkansas District Fair, Southeast Arkansas District Fair, Southwest Arkansas District Fair, and Arkansas-Oklahoma State Fair. Contestants representing the Four States Fair in Texarkana must be a legal resident of and attend school in Arkansas. If a District winner is also a County winner, the contestant must represent the District at the State Fair Contest, and the county which the contestant once represented will be allowed to send a runner up to compete in the State Youth Talent Contest. PLEASE NOTE THAT SOME COUNTY FAIRS ARE NOT NECESSARILY IN THE SAME REGION AS THE DISTRICT.
9. Entries to the Arkansas State Fair Youth Talent Contest are limited to one act in each of the six (6) categories from each County or District Fair sanctioned in the State of Arkansas. Counties with two recognized Arkansas fairs are allowed to send one act for each of the 6 categories from each fair providing that each holds a sanctioned Youth Talent Contest. Any tie at the County or District level must be broken prior to entry in the State Contest. If a County or District Fair sends more than one act in any one category, all the acts in that category from that County or District will be disqualified.
10. In the event a County or District winner is unable to compete at the State Contest, the County or District Contest Official can appoint a runner-up to represent their fair.
11. Once named the winning act at the County or District level, no substitution of individuals or change in category will be allowed for the State Contest. Contestants may change music selection only.
12. All acts must be performed on the stage. Please keep the stage dimensions in mind when preparing your talent presentation: 40 feet in length, 24 feet in depth, and 2 feet in height. Dimensions are approximate.
13. Contestants are required to be on time for all rehearsals and contests. Absent or tardy contestants are subject to disqualification, at the discretion of the Contest Director and State Fair Management.
14. Entry forms must be filled out completely and signed by each of the following: (1) contestant (s); (2) contestant's parent or guardian; (3) an authorized County or District Fair Official. Acts with 5 or more contestants can designate one responsible adult for the group to sign the entry form who must also furnish a copy of the contest rules to each contestant in the act. Entry forms should be submitted to the State Fair Office IMMEDIATELY FOLLOWING THE COUNTY OR DISTRICT CONTEST.
15. The final deadline to submit Youth Talent Entry Forms is October 8, 2009. Entry Forms may be faxed, mailed or hand delivered. The Arkansas State Fair and Livestock Show Association are not responsible for items lost or delayed in transit by any shipping method. **LATE ENTRY FORMS WILL RESULT IN LENGTHY DELAYS AT THE GATE.** We recommend that entries are sent in early, and that contest participation is confirmed prior to your arrival on the fairgrounds.
16. Any display of poor sportsmanship and/or unbecoming conduct, any interference and/or disturbance, or any other behavioral problem created by a contestant, parent, relative, or even a supporter of a contestant could result in disqualification of the contestant not only from this year's contest but also from future participation.
17. Any inappropriate lyrics of a song in the vocal and variety categories or inappropriate moves in the dance and variety categories will result in immediate disqualification. The contest director has the right to interrupt a performance if it is not deemed suitable for the Youth Talent Competition.
18. No decorative or background props of any kind will be allowed. A prop must be used as a functional part of the contestants act. Questionable props must be discussed and approved by the State Contest Director before arrival.

19. THE DIRECTOR OF THE ARKANSAS STATE FAIR YOUTH TALENT CONTEST RESERVES THE FINAL AND ABSOLUTE RIGHT TO INTERPRET THESE RULES AND ARBITRARILY SETTLE AND DETERMINE ALL MATTERS, QUESTIONS AND DIFFERENCES IN REGARD THERETO, OR OTHERWISE ARISING OUT OF OR CONNECTED WITH, OR INCIDENT TO THE CONTEST, AND THE RIGHT TO AMEND OR ADD TO THESE RULES AS THEIR JUDGMENT MAY DETERMINE. ANY CONTESTANT WHO FAILS TO ABIDE BY ANY OF THE ABOVE RULES WILL BE DISQUALIFIED FROM THE REGIONAL AND STATE CONTESTS BY THE STATE CONTEST DIRECTOR.

## **ENTRY FORMS**

Contestants may obtain Entry forms ONLY from the County / District Fair Manager or designated Contest Director, NOT THE STATE FAIR OFFICE. Entry forms must be filled out completely, including authorized signatures (see Rule #14) and sent to the State Fair Office. NO ADDITIONS OR CORRECTIONS WILL BE ALLOWED ONCE THE ENTRY FORM IS SUBMITTED. Avoid complications and delays at registration; submit entry early, keep a copy, and confirm participation prior to arrival on the fairgrounds. Acts that include 5 or more contestants should either come together or distribute copies of the entry form to all participants. BRING A COPY OF THE ENTRY FORM WITH ALL REQUIRED SIGNATURES WITH YOU TO REGISTRATION.

## **LENGTH OF PERFORMANCE**

Any act must not exceed the 3-minute time limit (including recorded introduction). Cassette/CD accompaniment is also subject to the same 3-minute time limit. All acts are limited to a 1-minute time limit in setting up equipment. NO EXCEPTIONS. Setups and performances will be timed. There will be a 15 point penalty for running over on setup time.

## **COMPETITION CATEGORIES**

There are six (6) categories in the Arkansas State Fair Youth Talent Contest. Competing acts must qualify by one of the following category descriptions:

1. **VOCAL SOLO** shall consist only of a vocal performance by one vocalist. No other talent may be performed in conjunction with the vocal solo. Tapes / CD's used for accompaniment will be allowed to provide limited vocal background.
2. **VOCAL GROUP** shall consist of two or more vocalists. No other talent may be performed. Tapes / CD's used for accompaniment will be allowed to provide limited vocal background.
3. **INSTRUMENTAL SOLO** shall consist of an instrumental performance without vocal utterance by one performer. Taped accompaniment may be used. Contestants are encouraged to memorize their piece rather than use sheet music on stage. An electric key board will be provided by the State Fair for Instrumental Solo Contests. No piano is available.
4. **DANCE SOLO** shall consist of one dancer. No other talent may be displayed in conjunction with the dance performance. All types of dancing will be judged in this category – tap, jazz, ballet, folk, ethnic, fad, etc. Gymnastics, tumbling, acrobatics, or any other form of gymnastics is not included in this category. However a dance routine can include a maximum of two gymnastic or acrobatic stunts.
5. **DANCE GROUP** shall consist of two or more dancers. No other talent may be displayed in conjunction with the dance performance. The same types of dancing as listed under Dance Solo are allowed.

6. **VARIETY** shall consist of a performance of one or more persons. This category is intended to provide a proper showcase for those acts in which multiple talents are displayed. Acts that fit the description of any other category will not be allowed to compete in this category. The following acts qualify for this category: song and dance, vocal and live instrumental, lip sync, pantomimes, impersonations, skits, juggling, ventriloquism, magic, and any other talent not applicable to any of the other categories. No act may include a drum set(s) or more than 2 electric instruments and 1 amplifier. This category does not include bands. No baton acts or any form of gymnastics are included in this category.

## **INSTRUMENTS AND MUSICAL ACCOMPANIMENT**

An electronic keyboard is provided (not a piano) on stage and adequate plug-ins for electric instruments are available. Professional sound equipment including cassette/CD player and 4 microphones are provided, and their use is required. No personal cassette players or microphones will be allowed. Any act which includes self-accompaniment will be considered a multiple talent and must be entered in the Variety Category.

Musical accompaniment for any act must be recorded. Contestants must furnish their own cassette/CDs, which must contain only the music needed for performance and must not be longer than 3 minutes. **ANY ACT WHOSE CASSETTE/CD CONTAINS MORE THAN THE MUSIC NEEDED FOR THEIR PERFORMANCE WILL BE AUTOMATICALLY DISQUALIFIED.** It is recommended you bring a second cassette/CD to have in case of an emergency. All cassette/CDs must be properly cued in advance and should be of good quality.

All cassette/CDs should be clearly marked with contestant(s) name, county/district represented, time of tape, and music title. All cassette/CDs must be claimed at the sound table immediately following the contest. The Arkansas State Fair Youth Talent Contest assumes no responsibility for cassettes and CDs left unclaimed.

## **REHEARSAL**

Every act will be afforded rehearsal time only once prior to Regional Contests. **All contestants must rehearse** or they will not be allowed to compete. **NO EXCEPTIONS.** While it would be to their best advantage to do so on the day of their Regional Contest, contestants that are unable to rehearse that day because of an **emergency** may request an alternate or additional rehearsal time from the State Contest Director. Heavy traffic is not a valid excuse for being late. For further details, the County or District Contest Director should contact the State Fair office not more than 48 hours prior to the competition.

## **DRESSING AND BACKSTAGE**

The dress code is completely optional, but attire must be in good taste and suitable for performance. All acts will be judged on talent, appearance, preparedness and entertainment value. All contestants' appearance and talent packages are subject to approval of the State Contest Director. Dressing areas are provided for contestants who will perform in costume. **ONLY ONE RESPONSIBLE ADULT PER ACT** will be allowed in the dressing area to help contestants get ready. **NO VISITORS ARE PERMITTED IN THE DRESSING AREA INCLUDING PROFESSIONAL HAIRDRESSERS, MAKEUP ARTISTS, TALENT COACHES, FAMILY OR FRIENDS.**

**ONLY CONTESTANTS WILL BE ALLOWED BACKSTAGE**  
**FAILURE TO ABIDE BY COMPETITION RULES MAY RESULT IN CONTESTANT DISQUALIFICATION.**

## **REGIONAL CONTESTS**

Each Regional Contest will be held in the Arkansas Building located on the southwest side of the Fairgrounds. The gates and traffic patterns at the south end of the fairgrounds have been modified. Enter the fairgrounds through Gate 11 **NO EARLIER THAN 10:00 AM.** The building will not be available until Registration at 11:00 AM. A guard will direct you to the Arkansas Building if you identify yourself as Youth Talent contestants. Only contestants and chaperones will be allowed free admission and parking when entering the grounds the first time. All others must pay gate admission and parking. No parking is available at the Arkansas Building. Contestants will be allowed to unload vehicles at the building and then directed by security personnel to park elsewhere.

Registration and rehearsals for each Regional Contest will begin at 11:30 AM. It is recommended that you stay on the grounds between the end of rehearsal and contest check-in time. Anyone who leaves the grounds, including contestants and chaperones, must pay gate admission and parking when they return.

Contestants must be present no later than 6:00 PM to prepare for the contest at 7:00 PM. Those returning to the grounds must allow for traffic delays. Heavy traffic is not an acceptable excuse for being late. Roll Call is at 6:00 PM. Those not present are subject to disqualification.

One winner in each category will be selected from each region to return to the finals on Saturday. Regional winners will be given instructions regarding the Final Competition on Saturday night.

## **FINALS**

The Regional Winners of each category will return to the finals on Saturday. No substitution of any individuals in any act will be allowed, and contestants must perform the same act as they did in the Regional Contest.

The finals will be held in the Arkansas Building. **BE SURE TO BRING TAPES / CD'S WITH YOU.** All contestants in the finals must report to the Arkansas Building for a 3:00 PM rehearsal to learn an opening production number. No rehearsal for individual talent numbers will be permitted. Contestants will be excused at the end of rehearsal, but must report back for roll call at 6:00 PM. The competition will begin at 7:00 PM.

A winning act from each category will be announced. One of those acts will be named the Grand Champion and be awarded an additional prize(s). Of the non-finalists, one will be chosen to receive the Bob Evans Memorial Award.

## **JUDGING**

The judges will be appointed by the Arkansas State Fair & Livestock Show. They will be persons well qualified to judge a contest of this kind. Their decision will be final. Judges scores are confidential and critiques are NOT allowed to be given to anyone. All acts will be judged on talent, appearance, preparedness and entertainment value. The judges will be required to break any tie(s) by considering the overall appeal of an act.

## **AWARDS**

1. **Regional Winners:** Trophy to the best act from each category and the right to return to the finals on Saturday.
2. **Final Winners:** Trophy and a minimum of a \$150 to the First Place act in each category.
3. **Grand Champion:** Trophy and an additional monetary award to the best over-all act.
4. **Bob Evans Memorial:** Trophy to the best nonfinalist at each competition.

## REGIONS

The Arkansas State Fair Youth Talent Contest is divided into 4 Regions. FIND THE REGION YOUR FAIR IS IN AND COME ON THAT DAY. **CONTESTANTS MUST BE ON TIME FOR ALL PHASES OF COMPETITION.**

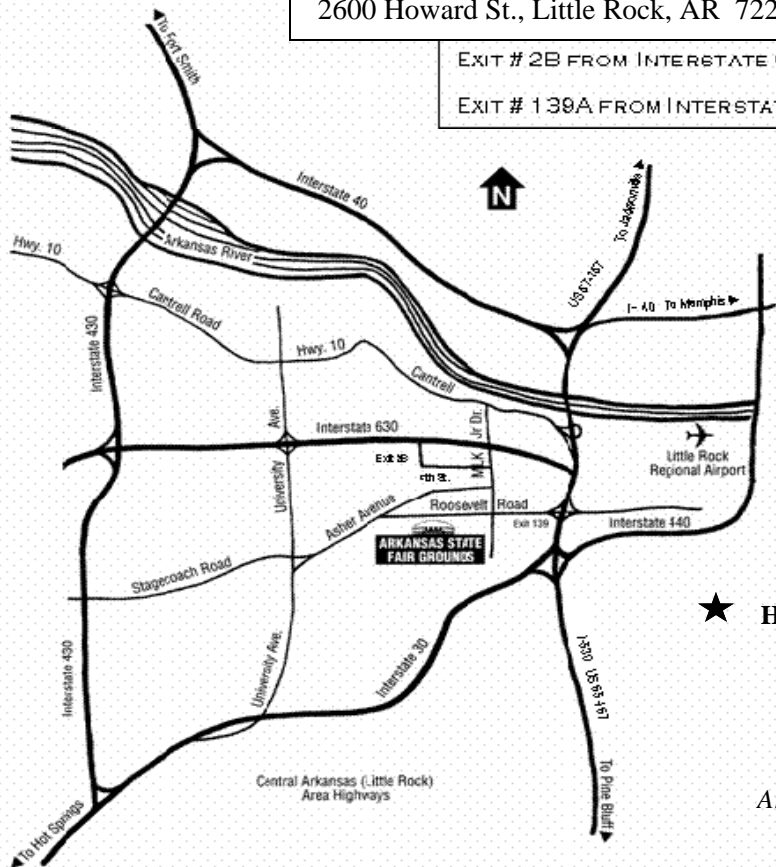
